

**L.A. LOUVER****Terms of Entrance & Release of Liability**

The World Health Organization has declared COVID-19 a worldwide pandemic. Due to the virus' capacity to transmit person-to-person, federal, state and local governmental authorities have authored recommendations of protocols and best practices for enhanced safety, some of which L.A. Louver Gallery, Inc. ("L.A. Louver") has chosen to implement.

The following are the Terms of Entrance for each visitor:

- Guests must wear a mask or face covering at all times while in the gallery.
- Guests must respect social distancing guidelines, maintaining at least a 6-foot distance from others.
- Guests must be prompt and arrive no more than five (5) minutes prior to the scheduled visit time. Early entry cannot be guaranteed.
- Additional, unregistered visitors are not permitted without advance notification and approval from the gallery.
- If a potential guest is experiencing COVID-19 related symptoms or has been exposed to COVID-19 within the last 14 days, visitors are asked to recover and reschedule the visit for a future date. Symptoms consistent with those of COVID-19 include (but are not limited to) flu-like symptoms, fever, shortness of breath, difficulty breathing, dry cough, runny nose, sore throat, or loss of taste or smell. Anyone exhibiting signs of illness will not be permitted entrance to the gallery.
- If a visitor is diagnosed with COVID-19 within 30 days after their visit to the gallery, the gallery must be notified immediately by phone at 310.822.4955 or by email at [appointments@lalouver.com](mailto:appointments@lalouver.com).
- Upon entering the gallery, all visitors must check in, and will be asked to answer a series of health questions.

By entering the gallery, you agree that the following statements are true:

- I have not experienced any of the following symptoms of COVID-19 within the past 14 days: flu-like symptoms, fever, shortness of breath, difficulty breathing, dry cough, runny nose, sore throat, or loss of taste or smell.
- I have not been in direct contact with anyone experiencing any of the following symptoms of COVID-19 within the past 14 days: flu-like symptoms, fever, shortness of breath, difficulty breathing, dry cough, runny nose, sore throat, or loss of taste or smell.
- I have not received a positive test result or been diagnosed with COVID-19 in the past 30 days or have been completely symptom-free or have received two negative test results since for the past 14 days.
- I am not awaiting the results of a test for COVID-19.
- I have not been in contact with a person who has been diagnosed with COVID-19 in the past 14 days.
- I have not traveled outside of the United States in the past 14 days.
- To the best of my knowledge, I have not been exposed to COVID-19 within the past 14 days.
- I acknowledge that the COVID-19 virus has a long incubation period during which carriers of the virus may not exhibit any symptoms and still be highly contagious.
- My visit to the gallery is voluntary, and I am fully and personally responsible for my own safety and actions during my visit.
- I understand and am fully aware that being in a space with other individuals, such as at the gallery, involves a certain degree of risk that could result in exposure to COVID-19 or other disease-causing organisms.
- With the knowledge of the risks involved, I hereby assume the risk of same, and agree to release and hold L.A. Louver Gallery, Inc., its employees, directors, officers and owners harmless from and against all claims and liabilities resulting from exposure to disease-causing organisms, including but not limited to COVID-19.
